DECREE OF THE HEAD OF INDONESIAN QUARANTINE AUTHORITY NUMBER 816 OF 2025

CONCERNING

DETERMINATION OF REGISTRATION OF TESTING LABORATORIES IN THE FRAMEWORK OF FRESH FOOD OF PLANT ORIGIN SAFETY SUPERVISION IN THAILAND

WITH THE GRACE OF GOD ALMIGHTY

HEAD OF INDONESIAN QUARANTINE AUTHORITY

Considering:

- a. that food safety supervision of the import of Fresh Food of Plant Origin (FFPO), is carried out in an integrated manner with quarantine measures, so that laboratory testing is required in the country of origin;
- b. that based on the results of the assessment of the testing laboratory in the context of fresh food of plant origin safety, Thailand has met the requirements to be determined;
- c. that based on the considerations as referred to in letters a and b, it is necessary to stipulate the Decree of the Head of Indonesian Quarantine Authority concerning Determination of Registration of Testing Laboratories in the Framework of Fresh Food of Plant Origin Safety Supervision in Thailand;

DECREE OF THE HEAD OF INDONESIAN QUARANTINE AUTHORITY CONCERNING DETERMINATION OF REGISTRATION OF TESTING LABORATORIES IN THE FRAMEWORK OF FRESH FOOD OF PLANT ORIGIN SAFETY SUPERVISION IN THAILAND

FIRST

Determinate the Registration of Testing Laboratory of Fresh Food of Plant Origin (FFPO) of Thailand as a FFPO safety testing laboratory authorized to issue Certificate of Analysis for FFPO from Thailand which will be imported into the territory of the Unitary State of the Republic of Indonesia.

SECOND

The list of FFPO safety testing laboratories as referred to in the FIRST dictum is listed in Annex I which is an integral part of this Decree of the Head of Authority.

THIRD

In the event of changes in data related to laboratory registration (accreditation status, address, etc.) or data on pesticides used or prohibited in the country of origin, the Competent Food Safety Authority (OKKP) of Thailand is obliged to immediately submit this information to the Indonesian Quarantine Authority.

FORTH : The types of FFPO and chemical and biological contaminants that must be tested by the

FFPO safety testing laboratory of Thailand as referred to in the FIRST dictum are listed in

Annex II which is an integral part of this Decree of the Head of Authority.

FIFTH : This Decree of the Head of Authority shall come into force on the date of stipulation.
